Learned Standing Counsel for the State has, however, submitted that since the writ petitioner was recruited as a **temporary** constable in the PAC, Regulation 541 of the Police Regulation would not be applicable and that the **impugned order dated** 30 March 1993 by which the services of the writ petitioner had been dispensed **in accordance with the 1975 Rules**, does not suffer from any **illegality**. Learned Standing Counsel also submitted that order is not punitive in nature.

We have considered **(80)** the submissions advanced by the learned counsel for the parties.

The writ petitioner was recruited as constable in PAC on **[100]** 3 November 1986. The writ petitioner stated in the **writ petition** that **appointment** letter was not issued. In the **{120}** counter affidavit, a specific stand has been taken that the writ petitioner was appointed on purely temporary basis and that **he had not been** appointed against a **substantive** vacancy nor was he placed on probation. In the rejoinder affidavit, no document **(160)** has been filed to **controvert** the statement made in the **counter**

affidavit and all that has been stated is that the services of a public servant who has continued in service for more than three years cannot be terminated like **[200]**
